#### **Operating instructions**

- 1) Unit should be placed as high as possible in the room/ car to be treated, as ozone is heavier than air and circulation will be assisted with height.
- 2) Plug power adaptor (12 Volt DC) into a standard Power Point or to a car lighter socket if used inside a car.
- 3) If used directly on surface (fruit, wounds etc) can be placed close.
- 4) It is recommended that dosage time is gauged by sensing ozone odour about 2 meters from unit. If Ozone is noticed, the unit can be switched off and time for treatment calculated.
